- 1. THE SHERIFF AND CONSTABLES ARE THE HIGHEST ELECTED POLICE AUTHORITY(S) IN THIS COUNTY OF EL PASO. THEY ARE MOST CRITICAL IN PROVIDING GOOD PUBLIC SAFETY IN THE AREA.
- 2. FOR PUBLIC SAFETY, ALL CONTROL SUPERVISION AND DIRECTION OF ANY POLICE ACTIONS DONE OR NOT DONE IN THIS COUNTY, SHOULD AND MUST BE UNDER SUCH HIGHEST ELECTED CONTROL.
- 3. DICTATORS DON'T NEED MUCH VOTER APPROVAL, TO DO WHATEVER THEY FEEL LIKE DOING. IN OUR CONSTITUTIONAL REPUBLIC, ELECTED OFFICIALS MUST KEEP ALL LOCAL POLICE POWER TO COMPEL CITIZENS TO DO THINGS WITHOUT THEIR CONSENT, UNDER VERY STRICT CONTROL.
- 4. AS IN THE ASSERTION OF THIS PETITION, THE SAID OFFICIAL ELECTED POLICE LEADERSHIP OF THIS COUNTY, BE ALWAYS WELL EMPOWERED, TO TIMELY ACCOMPLISH GOOD POLICING, WELL DISCOURAGING AND HOPEFULLY PREVENTING ANY POSSIBLE IMPROPER OR FAILED, NECESSARY POLICE ACTIONS DURING THEIR TERM OF OFFICE.
- 5. WHILE IN OFFICE, THE SAID ELECTED POLICE OFFICER(S) MUST HAVE AT LEAST THREE WAYS TO MAINTAIN THEIR COMMAND AND CONTROL OVER ALL ASSETS AND FACETS OF ALL POLICING. 6. MORE POLICE TRAINING MAY BE NEEDED TO IMPROVE PERFORMANCE. REQUIRE MANDATORY POLICE TRAINING, PERHAPS IN SOME FORM OF POLICE SCHOOL DETENTION, RUN BY THE BEST OFFICER POLICE PROFESSIONALS, (PERHAPS RETIRED).
- 7. FOR WHATEVER REASON, INCOMPETENCE CAN'T BE TOLERATED BY ELECTED POLICE LEADERSHIP. IN EFFECT ALL THOSE WHO TIMELY FORCE COMPLIANCE WITHOUT CONSENT, ARE DOING POLICE WORK UNDER LICENSE TO DO SO. TO INSURE PUBLIC SAFETY IN THIS COUNTY, THE SHERIFF AND CONSTABLES CAN REVOKE, AS THEY SEE FIT DURING THEIR TERM OF OFFICE, ANY QUALIFICATIONS TO DO POLICE WORK OF ANY WAY SHAPE AND KIND. CONSTABLES STARTED OUT MANAGING URBAN POLICE WORK SO THAT IS WHAT THEY SHOULD IN THEIR AREAS SPECIALIZE IN DOING. FROM THE BEGINNING OF ENGLISH HISTORY, THE SHERIFF WAS THE EXECUTIVE BRANCH OF LOCAL GOVERNMENT MANAGING ANYTHING RESEMBLING POLICE WORK. ALL WORK QUALIFICATIONS TO ENFORCE COMPLIANCE IS REVOCABLE IMMEDIATELY, TO PROTECT THE PUBLIC. DURING THE SAID ELECTED POLICE LEADERS' TERM OF OFFICE IN THIS COUNTY; PUBLIC SAFETY REQUIRES SUCH GOOD ELECTIVE MANAGEMENT, OF ALL EFFORTS TO COERCE COMPLIANCE.
- 8. THE ELECTED POLICE LEADERSHIP MAY ASSESS FINES AGAINST
 OFFICIALS/INDIVIDUALS/ENTITIES DOING POLICE ACTIONS AGAINST THE CONSENT OF THOSE
 WHO APPEAR VICTIMIZED. FINES PLACED ON INDIVIDUALS MAY BE UP TO \$10,000.00 PER
 INSTANCE PER DAY, AS MAY BE CONSIDERED REASONABLE UNDER THE CIRCUMSTANCES.
 \$66,000.00 SIMILARLY AGAINST ENTITIES, SUCH FINES APPEALABLE WITHIN 10 DAYS TO A
 ELECTED COUNTY JUDGE OR PROSECUTOR, WHO RECEIVED AT LEAST 60% OF THE VOTE IN
 THEIR ELECTION. OR OUR GOOD TEXAS GOVERNOR.
- 9. TO KNOW FOR SURE WHAT IS GOING ON, THE ELECTED POLICE LEADERSHIP OF THIS COUNTY, MUST HAVE FULL SUBPOENA POWERS, ONLY LIMITED BY THE U.S. CONSTITUTION 5TH AMENDMENT AGAINST SELF INCRIMINATION UPON AA THOSE DOING POLICE ACTIONS.

 10. NEVER MUST THE DICTATES OF THE ADMINISTRATIVE STATE PREVAIL OVER WHAT THE ELECTED POLICE LEADERSHIP OF THIS COUNTY CONSIDERS, THE MOST JUST AND PROPER LAW ENFORCEMENT. THE REMAINING PORTION OF THIS PETITION PROTECTS AGAINST OFFICIAL ABUSE.
- 11. IN FULFILLMENT OF THE US CONSTITUTION EQUAL PROTECTION OF THE 14TH AMENDMENT IMMUNITY FROM LIABILITY SHALL NO LONGER EXIST FOR ANY OFFICIALS, MORE THAN IT EVER

DOES FOR ANY ORDINARY CITIZEN(S) OF THIS COUNTY.

- 12. HAVING LONG BEEN THE PRACTICE AND LEGAL CUSTOM BY THE CITY OF EL PASO, IN IT'S MUNICIPAL CRIMINAL COURT OF RECORD. ANY LOCAL ATTORNEY CAN AND SHOULD, AS DOES THE UNELECTED PRIVATE ATTORNEY CITY PROSECUTOR, IN THIS COUNTY, EFFECTIVELY MAKE LEGAL CHARGES AND PROSECUTE, WHENEVER THE ELECTED DA, COUNTY ATTORNEY AND OR TEXAS ATTORNEY GENERAL EFFECTIVELY RECEIVING AFTER 60 DAYS LEGAL NOTICE DECLINES TO PROSECUTE, CRIMINALLY AND OR CIVILLY.
- 13. ALL CRIMINAL AND COURT CONVICTIONS WITHOUT INTENT WRITTEN IN THE CHARGES, SHALL BE CONSIDERED NULL AND VOID FROM THEIR INCEPTION. A CARJACK VICTIM TIED UP, UNCONSCIOUS IN THE BACK SEAT, SHOULD NOT BE CONSIDERED GUILTY OF SPEEDING DOWN THE HIGHWAY, JUST BECAUSE THE PROSECUTOR DIDN'T HAVE TO PROVE ACTUAL INTENT TO ILLEGALLY SPEED DOWN THE HIGHWAY, TO BE CONSIDERED GUILTY. IN THIS COUNTRY, THE RULE OF LAW MUST NOT BE SO FLAGRANTLY DISREGARDED. NO ONE SHOULD EVER BE PUNISHED FOR A CRIME, THEY COULDN'T BE ALLOWED TO PROVE THEY HAD NO INTENT TO COMMIT. INCIDENTALLY THE CITY PROSECUTOR(S) FAILURE TO INCLUDE INTENT IN CRIMINAL CHARGES FOR PERHAPS THE LAST 40 YEARS, SHOULD APPROPRIATELY BY THIS PETITION JUSTIFY TIMELY REFUNDS TO ALL THOSE CONVICTED WITHOUT INTENT WRITTEN INTO THE CHARGES.
- 14. IN THESE UPCOMING PERILOUS TIMES, ALLOWING ANY LACK OF CONTROL OF LOCAL POLICE BY ELECTED POLICE LEADERSHIP, OR PROSECUTORIAL BIAS AGAINST CITIZENS, IS AN UNFORGIVABLE FUTURE DISASTROUS RECIPE FOR FUTURE BUREAUCRATIC INCOMPETENCE IF NOT UNLIMITED POLICE ATROCITIES. ZORRO
